Cleanup Initiative

Board members are working with homeowners to clean up high traffic areas and zones littered with trash. An area along the creek was completed in March and the 56th street frontage area is on the April schedule. Homeowners are to keep their property including easements, bordering streets, curbs, and storm drains cleaned up and free of debris.

Covenant Enforcement - Community Reviews

Community reviews resume this month! Please promptly correct violations, if received. Failure to comply can result in fines or the work being scheduled by PMI and billed to homeowners. Together we can improve and maintain the beauty of our community.

Covenant Enforcement - Delinquent Assessments

Liberty Creek South assessments were due March 1. Late charges have been applied to delinquent accounts and notices sent to homeowners. Nonpayment of assessments when due may result in legal action. Avoid additional fees by paying delinquent assessments per late payment notifications. When an account is assigned for legal action, all communications by the delinquent owner must be directed to the attorney. Additionally, the homeowner's online payment privileges through the property manager's website shall be revoked. Homeowners whose accounts have been assigned for collections will receive communications from Kovitz Shifrin Nesbit (KSN.)

- 1. Complete and sign the <u>Liberty Glen Amenities Swimming Pool Registration Form</u> available at <u>www.libertyglenamenities.com</u> and <u>https://pmimer.cincwebaxis.com</u>. The form can be printed and completed prior to taking it to the clubhouse on the registration dates of May 18 and 20 and blank forms will also be available for completion at the clubhouse on the registration dates.
- 2. LGA Property Manager will -
 - ✓ Verify homeowner eligibility.

Homeowner assessments and fees must be paid in full by May 15, 2023, for pool registration and card activation.

- ✓ Record pool pass number assigned by system on the registration form.
- ✓ Sign and Date registration form in "For Office Use Only" space.
- ✓ Enter information from registration form into system for gate monitoring,
- 3. In addition to using the same pool passes as last year, wristbands will be issued for the adults and children in each registered household. The wristbands must be worn while at the pool.

The first card key is provided at no charge. Replacement cards are \$25.00 each. Pool guest(s) fee is \$5.00 per person per visit and a guest wristband will be issued.
